3 – Actions from Meeting 3 (13/06/19)

- 3.1 Meeting with LDC: Very constructive with and discussed ways LDC can be more involved with Newhaven and, specifically, as landlord and occupier on Avis Way & North Quay. Corinne has been invited to join a Newhaven Officers Group from the Local Authority.
- 3.2 Unit 9/10 Avis Way: metal shutters installed; verges & litter pick ongoing. Discussions continue in respect of hoardings we can use to tell the AWNQ story
- 3.3 LDC/ESCC Procurement: Still being identified. Both Lewes-Eastbourne and East Sussex (along with others) use <u>SE Shared Services</u>. For info, some London Boroughs use <u>this site</u>.
- 3.4 Culverts, Drains & Ditches: 4 local businesses were invited to quote for the clearance work. AS this is around £70-£100k we are talking to East Sussex, the Environment Agency and Lewes DC to understand their involvement, responsibilities and planned works
- 3.5 We have secured a meeting with ESCC Highways (1/10/19) to discuss how the road network can be improved and to submit our thoughts. This will include discussion on highways, pavements & verges

4 – Formalising the Avis Way & North Quay Business Forum

- 4.1 There has always been an ambition to formalise the structure of the Avis Way & North Quay Business Forum. This will help to give the AWNQ businesses more of a voice as well as act as a balance on the NEZ team to ensure that due consideration is given to this specific business community.
